

MOTORAMA KART INSTRUCTIONS AND RULES
BE SURE TO READ BEFORE COMING TO HARRISBURG
KART REGISTRATION IS SATURDAY 8:00 A.M. TO 10:30 A.M.
“IMPORTANT” - MAKE SURE YOU BRING YOUR M-4 RELEASE FORM FILLED OUT.

1. NO CANCELLATION OF RACE AND NO RETURN OF PRE-ENTRY OR TICKET FEES FOR ANY REASON.
2. NO KARTS MAY ENTER THE BUILDING BEFORE 7:00 A.M. SATURDAY. ANY KART FOUND IN THE PIT AREA BEFORE, WILL START IN THE REAR OF THEIR HEAT. THIS WILL BE POLICED BY THE MOTORAMA EVENT STAFF, NOT THE GO-KART STAFF.
3. REGISTRATION IS SATURDAY MORNING FROM 8:00 A.M. TO 10:30 A.M. ALL PRE-ENTERED RACERS MUST SIGN A RELEASE FORM AT CHECK IN TABLE AND PULL A PILL FOR YOUR HEAT STARTING POSITION.
4. YOU MUST REGISTER THROUGH THE KART ENTRANCE (#6 ON MAP).
5. THERE WILL BE NO PARKING IN AREA #3. DRIVER IS TO GO DIRECTLY TO AREA #11 AND PARK. HAVE PARKING PASS & TICKETS READY. BRING YOUR EQUIPMENT THROUGH THE TUNNEL UNDER CAMERON STREET (#12 ON MAP).
6. YOU ARE RESPONSIBLE FOR SHOWING UP ON TIME FOR ALL SCHEDULED ACTIVITIES.
7. DO NOT ATTEMPT TO START, RUN OR RACE YOUR KART INSIDE OR OUTSIDE THE BUILDING UNLESS INSTRUCTED TO BY AN OFFICIAL.
8. DO NOT CHAIN YOUR KART OR ANYTHING TO THE BUILDING, INSIDE OR OUTSIDE THE FARM SHOW COMPLEX.
9. INSIDE ELECTRIC HOOK-UP CARD MUST BE DISPLAYED AT YOUR PIT AREA AT ALL TIMES. NO CARD, \$60 FINE
10. ONLY THE FUEL STORED IN YOUR KART'S TANK WILL BE ALLOWED INSIDE. ALL SPARE FUEL MUST BE STORED IN THE OUTSIDE FUEL STORAGE AREA (#8 ON MAP). ALL REFUELING MUST BE DONE OUTSIDE. THIS IS BY ORDER OF THE FIRE MARSHALL.
11. NO ONE IS ALLOWED IN THE COMPLEX FROM MIDNIGHT SATURDAY UNTIL 7:30A.M. SUNDAY. OVERNIGHT SECURITY WILL BE PROVIDED.
12. WEIGHT BARS ALLOWED, BUT, MUST BE BOLTED TO THE FRAME ONLY. THERE IS NO SEAT HEIGHT OR ALIGNMENT REQUIREMENT EXCEPT, THAT IT CANNOT EXTEND PAST THE REAR AXLE. (PER - WKA RULES).
13. DURING ALL EVENTS, IF YOUR KART SHUTS OFF BEFORE THE GREEN FLAG IS THROWN, YOU WILL BE ALLOWED ONE RESTART.
14. BODIES ARE OPTIONAL, EXCEPT IN THE PEE WEE CLASS, WHERE THEY ARE MANDATORY. IF A BODY IS BROKEN DURING THE EVENT (IE: A PIECE IS MISSING) YOU WILL BE DISQUALIFIED, AND YOU MAY NOT USE IT FOR THE FEATURE. YOU WILL EITHER HAVE TO REPLACE IT OR RUN WITHOUT IT. IF A KART DOES NOT HAVE A BODY, THE BODY MOUNTING TABS MUST BE BENT UP OR REMOVED.
15. MUFFLERS ARE MANDATORY ON ALL KARTS!
16. KART NUMBERS MUST BE FIVE INCHES HIGH. STANDARD NUMBER PANELS (10" X 7") MUST APPEAR ON ALL FOUR SIDES OF THE KART. NUMBERS SHOULD BE LIGHT ON DARK OR DARK ON LIGHT. NO THREE DIGIT NUMBERS OR LETTERS WILL BE ALLOWED.
17. STATE LAW PROHIBITS BRINGING ALCOHOLIC BEVERAGES ON STATE PROPERTY WITHOUT A PERMIT. VIOLATORS WILL BE PROSECUTED. ALCOHOLIC BEVERAGES WILL BE SOLD AT THE CONCESSIONS STANDS IN THE COMPLEX.
18. THE DEPARTMENT OF ENVIRONMENTAL RESOURCES WILL CHECK THE CARBON MONOXIDE CONTENT IN THE BUILDING. WE MUST INSIST THAT YOUR VEHICLE BE JETTED PROPERLY AND NOT TO BE SMOKING EXCESSIVELY.
19. INSPECTION IS A “GENERAL” SAFETY INSPECTION. IT’S IMPOSSIBLE FOR US TO CHECK EVERYTHING ON EVERY KART. THEREFOR, IT BECOMES THE DRIVER OR KART OWNER’S RESPONSIBILITY TO MAKE SURE HIS/HER KART CONFORMSWITH WKA SPECIFICATIONS BEFORE AND AFTER A RACE. THE OFFICIALS AND TECH PERSONNEL HAVE THE RIGHT TO INSPECT ANY KART AT ANY TIME.
20. THE FOLLOWING ITEMS ARE NOT ALLOWED TO BE BROUGHT INSIDE THE FARM SHOW COMPLEX: PETS, ALCOHOLIC BEVERAGES, FUEL CANS, DRUGS, STICKERS, BALLOONS, OPEN FLAMES, SKATEBOARDS, SCOOTERS, BICYCLES, FIREARMS, LASER POINTERS, ROLLER BLADES, FOOTBALLS, FRISBEES, REMOTE CONTROL VEHICLES, FOOD, DRINKS OR COOLERS.
21. MOTORAMA EVENTS IS NOT RESPONSIBLE FOR FIRE AND THEFT TO ANYTHING THAT IS YOUR PROPERTY.
22. WE EXPECT TO CONTINUE KART RACING EACH YEAR IN THIS BUILDING. YOUR PATIENCE AND COOPERATION WITH THE STAFF AND MANAGEMENT AS WELL AS SPECTATORS WILL BE GREATLY APPRECIATED.
