

PRE-ENTERED QUARTER MIDGET RACERS INSTRUCTIONS

ON-SITE REGISTRATION SATURDAY 7:00 A.M. TO 10:00 A.M. IF SPACE IS AVAILABLE

- 1. TO ENTER THE COMPLEX COME INTO THE NORTH LOT (#1 ON MAP) BY TURNING AT INDUSTRIAL ROAD FROM CAMERON STREET. STREET SIGNS WILL SAY EXHIBITOR & VENDOR PARKING ONLY. ANY SPECTATORS DRIVING SEPARATELY MUST PARK IN THE SPECTATOR PARKING LOT BY TURNING ONTO ELMERTON AVENUE (#2 ON MAP)**
- 2. IF YOU HAVE A RESERVED PARKING PASS GO DIRECTLY TO THE RESERVED LOT (#7 ON MAP). THEY WILL PARK YOU IN THE RESERVED LOT (#5 ON MAP).**
- 3. IF YOU DO NOT HAVE RESERVED PARKING, YOU MAY PARK IN THE MAIN LOT (#4 ON MAP) AND BRING YOUR RACE VEHICLE TO THE SIGN-IN ENTRANCE (#9 ON MAP).**
- 4. MOTORAMA EVENTS PAID YOUR PARKING FEE TO THE FARM SHOW COMPLEX AND ALL COMPETITORS WILL RECEIVE ONE PARKING PASS. TO EXIT THE PARKING LOT USE (#10 ON MAP).**
- 5. NO CANCELLATION OF RACE AND NO RETURN OF PRE-ENTRY OR TICKET FEES FOR ANY REASON.**
- 6. CARS AND EQUIPMENT ARE ENCOURAGED TO BE BROUGHT IN ON FRIDAY, FROM 2:00 P.M. UNTIL 6:00 P.M. TO AVOID CONJESTION ON SATURDAY MORNING.**
- 7. REGISTRATION IS SATURDAY MORNING FROM 7:00 A.M. TO 10:00 A.M.**

- 8. INSIDE ELECTRIC HOOK-UP TAGS, MUST BE DISPLAYED / TIED ON YOUR MALE PLUG, CONNECTED TO ELECTRICAL RECEPTACLE.**
- 9. YOU MUST ENTER THROUGH THE RACER SIGN-UP ENTRANCE (#9 ON MAP).**
- 10. YOU ARE RESPONSIBLE FOR SHOWING UP ON TIME FOR ALL SCHEDULED ACTIVITIES.**
- 11. DO NOT ATTEMPT TO START, RUN OR RACE YOUR QUARTER MIDGET INSIDE THE BUILDING, UNLESS IT IS IN THE VERY NORTHWEST AREA, THROUGH THE STAGING AREA, IN THE PUSH OFF AREA.**
- 12. DO NOT CHAIN YOUR QUARTER MIDGET OR ANYTHING TO THE BUILDING, INSIDE OR OUTSIDE THE COMPLEX.**
- 13. ONLY THE FUEL STORED IN YOUR QUARTER MIDGET'S TANK WILL BE ALLOWED INSIDE. ALL SPARE FUEL MUST BE STORED IN THE OUTSIDE FUEL STORAGE AREA (#8 ON MAP). ALL REFUELING MUST BE DONE OUTSIDE. THIS IS BY ORDER OF FIRE MARSHALL.**
- 14. NO ONE IS ALLOWED IN THE COMPLEX FROM MIDNIGHT UNTIL 7:00 A.M. BOTH FRIDAY AND SATURDAY NIGHTS. OVERNIGHT SECURITY WILL BE PROVIDED.**
- 15. BE SURE TO BRING FUEL, TOOLS, RACING APPAREL AND ALL NECESSARY RACING EQUIPMENT. BE PREPARED TO CARRY THIS EQUIPMENT TO YOUR PIT AREA (#6 ON MAP).**
- 16. BE SURE TO BRING ALL TICKETS RETURNED TO YOU WHEN PRE-ENTERED. IF YOU FORGET THEM, YOU WILL HAVE TO PURCHASE NEW ONES AT THE DOOR!!**
- 17. MUFFLERS ARE MANDATORY ON ALL QUARTER MIDGETS!**
- 18. NUMBERS FOR YOUR QUARTER MIDGET WILL BE ASSIGNED AT SIGN-UP.**
- 19. STATE LAW PROHIBITS POSSESSION OF ALCOHOLIC BEVERAGES ON STATE PROPERTY WITHOUT A PERMIT. VIOLATORS WILL BE PROSECUTED. ALCOHOLIC BEVERAGES WILL BE SOLD AT THE CONCESSION STANDS IN THE COMPLEX.**

- 20. THE DEPARTMENT OF ENVIRONMENTAL RESOURCE WILL CHECK THE CARBON MONOXIDE CONTENT IN THE BUILDING. WE MUST INSIST THAT YOUR VEHICLE BE JETTED PROPERLY AND NOT TO BE SMOKING EXCESSIVELY.**
- 21. MOTORAMA ASSOCIATES IS NOT RESPONSIBLE FOR FIRE AND THEFT TO ANYTHING THAT IS YOUR PROPERTY.**
- 22. THE FOLLOWING ITEMS ARE NOT ALLOWED TO BE BROUGHT INSIDE THE FARM SHOW COMPLEX: PETS,ALCOHOLIC BEVERAGES, FUEL CANS, DRUGS, STICKERS, BALLOONS, OPEN FLAMES, SKATEBOARDS, SCOOTERS, BICYCLES, FIREARMS, LASER POINTERS, ROLLER BLADES, FOOTBALLS,FRISBEES, REMOTE CONTROL VEHICLES, FOOD, DRINKS OR COOLERS.**
- 23. WE EXPECT TO CONTINUE QUARTER MIDGET RACING EACH YEAR IN THIS BUILDING. YOUR PATIENCE AND COOPERATION WITH THE STAFF AND MANAGEMENT AS WELL AS SPECTATORS WILL BE GREATLY APPRECIATED.**
