VENDOR/EXHIBITOR AGREEMENT

MOTORAMA Events (Management) shall have the right to enforce these regulations and add to them as necessary. In consideration of the mutual covenants set forth below, the parties agree as follows:

LIABILITY: Each vendor/exhibitor is solely responsible for the space he has been allotted. Each vendor/exhibitor will be required at his own expense to reimburse MOTORAMA for any defacement, damages or injury to the premises within his contracted space, either by his exhibit or representative. All goods, wares, merchandise, personal items, etc. of any kind displayed at the show is understood to be at the owner's risk and by acceptance of loss or theft to any person or goods from any cause whatsoever and agree to hold and save the Management harmless and from any loss or damage by reason thereof. All vendor/exhibitors are encouraged to notify their own insurance company to provide coverage while at the show. By entering any MOTORAMA activity, I waive my right of privacy concerning injury information; all ambulance transportation charges will be billed to the patient.

EXHIBIT DAYS AND HOURS: Are set forth in the Schedule of Activities for the show.

TEAR-DOWN: No vendor/exhibit or any portion thereof may be removed during the show without prior written consent of Management. Vendors/exhibitors expressly agree that all parts of the exhibit will remain intact for the duration of the show.

GENERAL: Subletting of exhibit space is prohibited. Two or more firms may not exhibit in a single or shared space. Management reserves the right to prohibit an exhibit or a portion thereof which, in their judgment may detract from the character of the show. This restriction includes printed material, persons, things, displays and conduct.

Show Management will provide twenty-four hour security service in the show area. This service is included in the booth fee. We request that you cooperate with the guards during the show.

Vendor/exhibitor booths MUST conform and be able to pass fire inspections. It is required that only NON-FLAMMABLE materials be used by the vendor/exhibitors.

All vehicles retained inside show area and buildings must tape gas caps shut with duck tape. Battery cables must be disconnected and taped. No helium is allowed inside buildings.

Management and MOTORAMA Events do not assume any responsibility for the safety of vendors/exhibitors against fire, accidents, or any cause whatsoever, and is hereby released and discharged from any and all liability from any loss, injury or damages to persons or property that may be sustained during set-up, tear-down, or during show.

Show area occupied by vendors/exhibitors will be cleaned by show Management. Each vendor/exhibitor must cooperate and refrain from throwing refuse on the grounds, or anywhere which will endanger public safety or inconvenience other vendors/exhibitors. Vendors/exhibitors are responsible for cleaning and putting exhibits in proper condition thirty minutes before the show opens. Booths not cleaned one hour before opening will be cleaned at Management's discretion at the vendor/exhibitor's expense.

Vendor/exhibitor is responsible for purchasing the required licenses and official permits necessary for the purpose of displaying, exhibiting or selling at MOTORAMA.

All audio displays must maintain and abide by sound levels acceptable to Management.

Each vendor/exhibitor MUST have an attendant in charge at the exhibit all day during the show.

Vendors must comply with all sales tax laws and, at Management's request, provide sales tax number and federal tax identification number.

Vendor representatives wearing distinctive costumes, carrying banners or signs or handing out promotional material must remain in their own booths. Costumes must be appropriate to the show and approved by Management.

Management has the sole right to determine eligibility of any company or any product displayed in the show.

The operation of lotteries or games of chance is prohibited. Any recreational or pastime games are permitted only on written approval of Management.

Requests, including the description of the lottery or contest and items involved, must be submitted to Management at least thirty days prior to the show.

Use of any lights, sound or other materials that obstruct or disturb neighboring vendors/exhibitors is prohibited. Management shall determine if a violation exists.

Vendors/exhibitors must have available make, model, serial number, and color of all merchandise or property on display for immediate police investigation in case of loss or theft.

These RULES AND REGULATIONS have been prepared for the purpose of providing an attractive and successful show. In an effort to provide the best service to the public, Management reserves the sole privilege of interpreting the RULES AND REGULATIONS or to make such ruling as may appear to be for the best interests of the entire show. Any and all amendments to the RULES AND REGULATIONS will be applicable immediately and enforced promptly. Any vendor/exhibitor violating any of these RULES AND REGULATIONS will be notified verbally by Management and shall comply with said RULES AND REGULATIONS. If the verbal notification is not heeded, Management reserves the right to terminate Vendors/Exhibitors Contract and to occupy vendor's/exhibitor's space at its option. Management may also re-enter premises and take possession of the space occupied by the Vendor/Exhibitor and remove all persons, goods, merchandise or any other material at the vendor's / exhibitor's own risk and the vendor/exhibitor shall be responsible for and pay all expenses in connection with such removal and all damages which Management may incur and forfeit all monies paid to Management on account thereof.

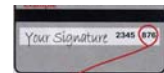
